In the fall, Good Samaritan Hospital Medical Center earned high marks from the Joint Commission during our survey. While Good Samaritan has been a center of excellence for cancer care, cardiac and stroke care, breast imaging, bariatric/weight loss surgery and adult and pediatric trauma, the recent ACS verification exemplifies the hospital's ongoing investment and commitment to expert care.

This year we will be expanding the St. Francis Open Heart Surgery Program at Good Samaritan Hospital Medical Center to meet the demand for our expert cardiac services. We are also busy working on the next center of excellence for you and your loved ones and are bringing the future of stroke and brain aneurysm care to the community. Before the end of the year we will introduce the Stroke and Brain Aneurysm Center of Excellence at Good Samaritan Hospital Medical Center which will treat the most complex cases with minimally invasive procedures, made possible by advanced imaging capabilities and a dedicated Neuro-Intensive Care Unit with 24/7 neuro-critical care programs. We are investing in this important program to provide you with a world-class center of excellence for stroke and brain aneurysm right here in your own backyard.

Good Sam Verified as An Adult and Pediatric Trauma Center

Designated as Level-II, the Trauma Center at Good Samaritan is one of only two hospitals in Suffolk County with ACS verification to treat both adults and children. With an Emergency Department that treats nearly 90,000 patients each year, the most of any facility in Suffolk County, this verification is a direct result of the investment and commitment the Center has made to patients on the south shore and all of Long Island.

“This is a result of significant investment by Catholic Health Services (CHS) and a lot of hard work by members of the trauma team at Good Sam,” said Christopher C. Raio, MD, MBA, FACEP, Chairman of the Department of Emergency Medicine at Good Samaritan and Chief of Emergency Medicine for CHS. “From the Emergency Department to hospital discharge, we work as a team to deliver the best possible trauma care for our patients.”

In collaboration with the Pediatric Critical Care Division, the Division of Trauma accepts severely injured children from other area trauma centers as well as from hospitals that are not trauma centers. To achieve this verification, Good Samaritan made several enhancements to its existing infrastructure, including a full-time pediatric surgeon, pediatric intensivist, trauma surgeon, and trauma care specialist.

AIMING FOR EXCELLENCE AND TRANSFORMING PATIENT CARE

In the next year, Good Samaritan Hospital Medical Center will be the first hospital on Long Island to offer streamlined care coordination through an exciting new system called Care Logistics. The “Aim 4 Excellence” project, and the advanced technology and tracking that is a part of it, will track patient

movement throughout the hospital and transform throughput, care quality and the experience for our patients. The project is expected to take

approximately 18 months with a completion date of May 2019. We are putting our patients first and the results will be faster access to superior care!

This past fall the Good Samaritan Brave Hearts hosted a festive brunch on the water in Bay Shore. If you are 70 ½ or older, you can transfer up to \$100,000 each year directly from your IRA to charity and not recognize it as income. Best of all, it also counts toward your minimum required distribution from the IRA for the year.
